OVERVIEW

Director: Christy Clark (Appointed by Governor and confirmed by the Senate)

Article XII, section 1, requires the legislature to provide for the Department of Agriculture to "protect, enhance, and develop all agriculture." The constitution also allows for special levies "for disease control and indemnification, predator control, and livestock and commodity inspection, protection, research, and promotion."

RELATED LEGISLATION PASSED IN 2023

During the 2021-2022 interim, the Department of Agriculture requested **five** bill drafts. Of the **three** drafted and introduced, **all** were passed and approved:

- **HB 93** Eliminates the noxious weed seed free forage advisory council; transfers duties to the noxious weed management advisory council; revises the makeup of the noxious weed management advisory council.
- **HB 94** Repeals Montana huckleberry filing law requirements.
- **HB 113** Repeals the requirements for licensing of hucksters.

Other agriculture related legislation:

HB 120	Allows the Department of Revenue to allow alcoholic beverage manufacturer tradeshows; allowing alcoholic beverage manufacturers to showcase products at tradeshows; and providing rulemaking authority.
HB 487	Prohibits seed cleaning or conditioning without department declaration. (Working on administration rules)
HB 738	Exempts the Montana Wheat and Barley Committee from state procurement requirements. (Working on policy)
HB 821	Appropriates money to the Department of Agriculture for grants to assist Yellowstone, Musselshell, and Stillwater Counties to combat infestations of certain weeds.
НЈ 7	Joint Resolution supporting the 100 th Anniversary of the Livingston Roundup Rodeo's 100 Buckin' Years Event.
HR 6	Resolution of the House of Representatives urging the United States Congress to implement country-of-origin labeling for beef and pork products.
SJ 9	Joint Resolution establishing the first week in April as Montana Soil Health Week and the first Wednesday in April as Soil Health Day.
SJ 13	Joint Resolution establishing June as Rangeland Appreciation Month.
