16	"28-2-724. Prohibition of contracts that restrict practice applicability exceptions. (1) A			
17	contract that creates or establishes the terms of employment, a partnership, or any other form of professional			
18	relationship with a health care provider described in subsection (2), may not restrict the right of the health care			
19	provider to:			
20	(a) practice or provide services for which the provider is licensed, in any geographic area and for any			
21	period, after the termination of the employment, partnership, or other form of professional relationship;			
22	(b) treat, advise, consult with, or establish a provider-patient relationship with any current patient of			
23	the employer or with a patient affiliated with a partnership or other form of professional relationship; or			
24	(c) solicit or seek to establish a provider-patient relationship with any current patient of the employer			
25	or with a patient affiliated with a partnership or other form of professional relationship.			
26	(2) The requirements of subsection (1) apply to contracts or agreements involving the following health			
27	care providers:			
28	(a) a psychiatrist or addiction medicine physician licensed under Title 37, chapter 3;
