

# REVIEW OF AGENCY-PROPOSED LEGISLATION

#### AGENCY BILLS


One of the duties common to interim committees under 5-5-215(1)(e) is to "review proposed legislation of assigned agencies or entities as provided in the joint legislative rules." These proposals become what are known as "agency bills". An "agency bill" is not the same as a "committee bill" (see page 2 for examples of each).

#### AUTHORIZATION TO DRAFT IS NOT ENDORSEMENT

An agency bill is "by request of" the agency and the committee's name does not appear on the bill draft. The agency is responsible for finding a bill sponsor and ensuring preintroduction.

The main reason for this process is to allow legislative staff to prepare these agency bills earlier in the fall prior to a legislative session, so that after the November election, bill drafters can focus on requests from newly elected legislators.
