

Montana 2022 Elk Counts

In 2022 several hunting districts were combined, renamed, or eliminated (see footnotes). In some cases counts aligning to new district boundaries were not available (indicated by "-") and FWP commission has not yet approved objective ranges (indicated by ""). Elk are counted in winter or spring by aircraft. It is not possible to count all elk in a management unit and elk plan objectives are based on "Observed Elk", which may be elk observed on trend areas in some cases. Counting elk is an inexact exercise subject to a multitude of weather and timing variables and elk movements between hunting districts. Therefore, counts in some years may not accurately reflect elk numbers and better counts from previous years are reported.
