


Access to Legal Education in Montana

- Law school deserts = lawyer deserts





ABA will not approve a fully online law school




ABA Hybrid / Online Programs











- Military-affiliated: 19%






PGLS vs. ABA

- 18 required experiential credits (vs. 6 min. for ABA)
- 1380 hrs. active engagement (vs. 1038 min. for ABA)
- Employment: 93.8%, \$104,220 vs. 94.7%, \$109,732




Bar Exam Pass Rates - California






Bar Exam Pass Rates - California
