19 ~~assessment, and taxation as agricultural land each year that none of the parcels is devoted to a residential,~~  
20 ~~commercial, or industrial use.~~

21 ~~(b)(i)~~ (i) Contiguous parcels of land ~~of 20 acres or more but less than 160 acres~~ under one ownership  
22 that are actively devoted to agricultural use are eligible for valuation, assessment, and taxation as agricultural

4 classification as provided in subsection (7). Land of ~~20 640~~ acres or more ~~but less than 160 acres~~ for which no  
5 application for agricultural classification has been made is idle land and is valued as provided in 15-6-133(1)(c)  
6 and ~~is~~ taxed as provided in 15-6-133(3). If land has been valued, assessed, and taxed as agricultural land in

 24 and with a business model that aims to produce agricultural goods for sale."

26 **Section 3.** Section 15-7-206, MCA, is amended to read:

27 **"15-7-206. Improvements on agricultural land.** (1) In determining the total area of land actively  
 28 devoted to agricultural use, there is included the area of all land under barns, sheds, silos, cribs, greenhouses,

1 and like structures, lakes, dams, ponds, streams, irrigation ditches, and like facilities.

2 (2) One acre of land beneath residential improvements on agricultural land, as described in 15-7-

3 202~~(1)(e)(ii)~~(3), is valued at the class with the highest productive value and production capacity of agricultural

4 land."

6 **Section 4.** Section 15-7-307, MCA, is amended to read:

7 **"15-7-307. Certificate -- exceptions.** The certificate required by this part applies to all transfers.

8 However, the certificate filed for the following transfers need not disclose the consideration paid or to be paid

9 for the real estate transferred:

10 (1) an instrument recorded prior to July 1, 1975;

11 (2) the sale of agricultural land totaling 640 acres or more when the land is used for agricultural  
12 purposes;

13 (3) the sale of timberland totaling 640 acres or more when the land is used for producing timber;

14 (4) a transfer by the United States, this state, or any instrumentality, agency, or subdivision of the  
15 United States or this state;

16 (5) an instrument that (without added consideration) confirms, corrects, modifies, or supplements a  
17 previously recorded instrument;

18 (6) a transfer pursuant to a court decree;

19 (7) a transfer pursuant to mergers, consolidations, or reorganizations of corporations, partnerships,  
20 or other business entities;

21 (8) a transfer by a subsidiary corporation to its parent corporation without actual consideration or in  
22 sole consideration of the cancellation or surrender of subsidiary stock;

23 (9) a transfer of decedents' estates;

24 (10) a transfer of a gift;

25 (11) a transfer between husband and wife or parent and child with only nominal actual consideration  
26 for the transfer;

27 (12) an instrument the effect of which is to transfer the property to the same party or parties;

28 (13) a sale for delinquent taxes or assessments, a sheriff's sale, or a sale pursuant to a bankruptcy



1 court order;

2 (14) a transfer made in contemplation of death."

4 **Section 5.** Section 15-10-420, MCA, is amended to read:

5 **"15-10-420. Procedure for calculating levy.** (1) (a) Subject to the provisions of this section, a  
6 governmental entity that is authorized to impose mills may impose a mill levy sufficient to generate the amount  
7 of property taxes actually assessed in the prior year plus one-half of the average rate of inflation for the prior 3  
8 years. The maximum number of mills that a governmental entity may impose is established by calculating the  
9 number of mills required to generate the amount of property tax actually assessed in the governmental unit in  
10 the prior year based on the current year taxable value, less the current year's newly taxable value, plus one-half  
11 of the average rate of inflation for the prior 3 years.

12 (b) A governmental entity that does not impose the maximum number of mills authorized under  
13 subsection (1)(a) may carry forward the authority to impose the number of mills equal to the difference between  
14 the actual number of mills imposed and the maximum number of mills authorized to be imposed. The mill  
15 authority carried forward may be imposed in a subsequent tax year.

16 (c) For the purposes of subsection (1)(a), the department shall calculate one-half of the average  
17 rate of inflation for the prior 3 years by using the consumer price index, U.S. city average, all urban consumers,  
18 using the 1982-84 base of 100, as published by the bureau of labor statistics of the United States department of  
19 labor.

20 (2) A governmental entity may apply the levy calculated pursuant to subsection (1)(a) plus any  
21 additional levies authorized by the voters, as provided in 15-10-425, to all property in the governmental unit,  
22 including newly taxable property.

23 (3)(a) For purposes of this section, newly taxable property includes:

- 24 (i) annexation of real property and improvements into a taxing unit;
- 25 (ii) construction, expansion, or remodeling of improvements;
- 26 (iii) transfer of property into a taxing unit;
- 27 (iv) subdivision of real property; and
- 28 (v) transfer of property from tax-exempt to taxable status.

1 (b) Newly taxable property does not include an increase in value that arises because of an  
2 increase in the incremental value within a tax increment financing district.

3 (4)(a) For the purposes of subsection (1), the taxable value of newly taxable property includes the  
4 release of taxable value from the incremental taxable value of a tax increment financing district because of:

- 5 (i) a change in the boundary of a tax increment financing district;
- 6 (ii) an increase in the base value of the tax increment financing district pursuant to 7-15-4287; or
- 7 (iii) the termination of a tax increment financing district.

8 (b) If a tax increment financing district terminates prior to the certification of taxable values as  
9 required in 15-10-202, the increment value is reported as newly taxable property in the year in which the tax  
10 increment financing district terminates. If a tax increment financing district terminates after the certification of  
11 taxable values as required in 15-10-202, the increment value is reported as newly taxable property in the  
12 following tax year.

13 (c) For the purpose of subsection (3)(a)(ii), the value of newly taxable class four property that was  
14 constructed, expanded, or remodeled property since the completion of the last reappraisal cycle is the current  
15 year market value of that property less the previous year market value of that property.

16 (d) For the purpose of subsection (3)(a)(iv), the subdivision of real property includes the first sale  
17 of real property that results in the property being taxable as class four property under 15-6-134 ~~or as~~  
18 ~~nonqualified agricultural land as described in 15-6-133(1)(c).~~

19 (5) Subject to subsection (8), subsection (1)(a) does not apply to:

- 20 (a) school district levies established in Title 20; or
- 21 (b) a mill levy imposed for a newly created regional resource authority.

22 (6) For purposes of subsection (1)(a), taxes imposed do not include net or gross proceeds taxes  
23 received under 15-6-131 and 15-6-132.

24 (7) In determining the maximum number of mills in subsection (1)(a), the governmental entity:

- 25 (a) may increase the number of mills to account for a decrease in reimbursements; and
- 26 (b) may not increase the number of mills to account for a loss of tax base because of legislative  
27 action that is reimbursed under the provisions of 15-1-121(7).

28 (8) The department shall calculate, on a statewide basis, the number of mills to be imposed for

1 purposes of 15-10-109, 20-9-331, 20-9-333, 20-9-360, and 20-25-439. However, the number of mills calculated  
2 by the department may not exceed the mill levy limits established in those sections. The mill calculation must  
3 be established in tenths of mills. If the mill levy calculation does not result in an even tenth of a mill, then the  
4 calculation must be rounded up to the nearest tenth of a mill.

5 (9)(a) The provisions of subsection (1) do not prevent or restrict:

6 (i) a judgment levy under 2-9-316, 7-6-4015, or 7-7-2202;

7 (ii) a levy to repay taxes paid under protest as provided in 15-1-402;

8 (iii) an emergency levy authorized under 10-3-405, 20-9-168, or 20-15-326;

9 (iv) a levy for the support of a study commission under 7-3-184;

10 (v) a levy for the support of a newly established regional resource authority;

11 (vi) the portion that is the amount in excess of the base contribution of a governmental entity's

12 property tax levy for contributions for group benefits excluded under 2-9-212 or 2-18-703;

13 (vii) a levy for reimbursing a county for costs incurred in transferring property records to an

14 adjoining county under 7-2-2807 upon relocation of a county boundary;

15 (viii) a levy used to fund the sheriffs' retirement system under 19-7-404(3)(b); or

16 (ix) a governmental entity from levying mills for the support of an airport authority in existence prior

17 to May 7, 2019, regardless of the amount of the levy imposed for the support of the airport authority in the past.

18 The levy under this subsection (9)(a)(ix) is limited to the amount in the resolution creating the authority.

19 (b) A levy authorized under subsection (9)(a) may not be included in the amount of property taxes

20 actually assessed in a subsequent year.

21 (10) A governmental entity may levy mills for the support of airports as authorized in 67-10-402, 67-

22 11-301, or 67-11-302 even though the governmental entity has not imposed a levy for the airport or the airport

23 authority in either of the previous 2 years and the airport or airport authority has not been appropriated

24 operating funds by a county or municipality during that time.

25 (11) The department may adopt rules to implement this section. The rules may include a method for

26 calculating the percentage of change in valuation for purposes of determining the elimination of property, new

27 improvements, or newly taxable value in a governmental unit."

1           **Section 6.** Section 15-30-2660, MCA, is amended to read:

2           **"15-30-2660. (Temporary) Taxpayer integrity fees.** (1) (a) The department shall assess a fee as  
3 provided in subsection (2) for a taxpayer who is a participant in the Montana Health and Economic Livelihood  
4 Partnership Act provided for in Title 53, chapter 6, part 13, and Title 39, chapter 12, and owns:

5           (i) equity in real property or improvements to real property, or both, that exceeds the limit  
6 established for homesteads under 70-32-104 by \$5,000 or more, if the real property is not agricultural land;

7           (ii) more than one light vehicle when the combined depreciated value of the manufacturer's  
8 suggested retail price totals \$20,000 or more and the participant's equity in the vehicles exceeds that combined  
9 depreciated value by \$5,000 or more; or

10          (iii) agricultural land with a taxable value in excess of \$1,500 a year.

11          (b) For the purposes of subsection (1)(a):

12          (i) "real property or improvements to real property" does not include property held in trust by the  
13 United States for the benefit of a Montana federally recognized Indian tribe; and

14          (ii) the depreciated value of the manufacturer's suggested retail price must be computed as  
15 provided in 61-3-503(2).

16          (2) The fee is \$100 a month plus an amount equal to an additional \$4 a month for:

17          (a) each \$1,000 in equity value above the limits established in subsections (1)(a)(i) and (1)(a)(ii);

18 and

19          (b) each \$100 of taxable value in agricultural land above \$1,500.

20          (3)(a) The department shall assess a fee for an entity organized under 26 U.S.C. 501(d) and subject  
21 to taxes as provided in Title 15, chapter 31, if the entity has members who are receiving medicaid coverage  
22 under Title 53, chapter 6, part 13.

23          (b) The fee is equal to the state's share of the average annual cost per program participant, as  
24 defined in 53-6-1303, multiplied by the number of individuals in the 26 U.S.C. 501(d) organization who are  
25 receiving medicaid coverage because they are eligible under 53-6-1304, less the total annual amount the  
26 entity's members have paid in premiums.

27          (4)(a) For the purposes of calculating the fee required under subsection (3), the department of public  
28 health and human services shall provide the department of revenue by February 1 of each year with:

1 (i) the percentage of medicaid claims costs of program participants for which the state was  
2 responsible in the previous calendar year; and

3 (ii) the average annual cost of medical claims for program participants in the previous calendar  
4 year.

5 (b) The department of public health and human services shall post the average annual cost for a  
6 program participant on the department's website by February 15 of each year.

7 (5) An organization shall pay the fee provided for in subsection (3) as follows:

8 (a) on or before the last day of each month, the organization shall pay an estimated fee equal to  
9 one-twelfth of the most recently published annual cost per program participant; and

10 (b) on or before April 15 of each year, the organization shall report and pay any additional amount  
11 owed for the prior year or request a refund of any overpayment made in the prior year.

12 (6)(a) The department of public health and human services shall provide the department of revenue  
13 with the names of program participants and other necessary information to assist the department of revenue in  
14 administering and enforcing this section.

15 (b) The department of justice shall provide the department of revenue with vehicle registration  
16 information for the administration of this section.

17 (7) Fees collected pursuant to this section must be deposited in the Montana HELP Act special  
18 revenue account provided for in 53-6-1315.

19 (8) A fee remains until paid and may be collected through assessments against future income tax  
20 returns or through a civil action initiated by the state.

21 (9) For the purposes of this section, the following definitions apply:

22 (a)(i) "Agricultural land" means agricultural land as described in 15-7-202 that is taxed as class three  
23 property at the rate provided in 15-6-133.

24 (ii) The term does not include:

25 ~~(A) — parcels of land that are considered nonqualified agricultural land as provided in 15-6-133(1)(c);~~

26 ~~(B)~~(A) improvements to real property; or

27 ~~(C)~~(B) land held in trust by the United States for the benefit of a Montana federally recognized Indian

28 tribe.
