5	A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING EXEMPT ENTITIES TO REPORT BENEFICIAL USE
6	OF PROPERTY TO THE DEPARTMENT OF REVENUE; AND AMENDING SECTION 15-6-201, MCA."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
9	
10	NEW SECTION. Section 1. Beneficial use of exempt property reporting. (1) Except as provided
11	in 15-24-1203, property owned by an entity listed in 15-6-201(1)(a) and leased for the beneficial use of a non-
12	exempt entity is subject to taxation under Title 15, chapter 6.
13	(2) An entity granted an exemption under Title 15, chapter 6, part 2, that leases property for the
14	beneficial use of a non-exempt entity or for a non-exempt use shall report annually to the department. The
15	report must include a description of the leased property and a copy of the lease agreement.

17	Section 2. Section 15-6-201, MCA, is amended to read:
18	"15-6-201. Governmental, charitable, and educational categories exempt property. (1) The
19	following categories of property are exempt from taxation:
20	(a) except as provided in [section 1] and 15-24-1203, the property of:
21	(i) the United States, except:
22	(A) if congress passes legislation that allows the state to tax property owned by the federal
23	government or an agency created by congress; or
24	(B) as provided in 15-24-1103;
25	(ii) the state, counties, cities, towns, and school districts;
26	(iii) irrigation districts organized under the laws of Montana and not operated for gain or profit;
27	(iv) municipal corporations;
28	(v) public libraries;

1	(vi) rural fire districts and other entities providing fire protection under Title 7, chapter 33;
2	(vii) special districts created pursuant to Title 7, chapter 11, part 10; and
3	(viii) subject to subsection (2), federally recognized Indian tribes in the state if the property is
4	located entirely within the exterior boundaries of the reservation of the tribe that owns the property and the
5	property is used exclusively by the tribe for essential government services. Essential government services are
6	tribal government administration, fire, police, public health, education, recreation, sewer, water, pollution
7	control, public transit, and public parks and recreational facilities.
8	(b) buildings and furnishings in the buildings that are owned by a church and used for actual
9	religious worship or for residences of the clergy, not to exceed one residence for each member of the clergy,
10	together with the land that the buildings occupy and adjacent land reasonably necessary for convenient use of
11	the buildings, which must be identified in the application, and all land and improvements used for educational or
12	youth recreational activities if the facilities are generally available for use by the general public but may not
13	exceed 15 acres for a church or 1 acre for a clergy residence after subtracting any area required by zoning,
14	building codes, or subdivision requirements;
15	(c) land and improvements upon the land, not to exceed 15 acres, owned by a federally recognized
16	Indian tribe when the land has been set aside by tribal resolution and designated as sacred land to be used
17	exclusively for religious purposes;
18	(d) property owned and used exclusively for agricultural and horticultural societies not operated for
19	gain or profit;
20	(e) property, not to exceed 80 acres, which must be legally described in the application for the
21	exemption, used exclusively for educational purposes, including dormitories and food service buildings for the
22	use of students in attendance and other structures necessary for the operation and maintenance of an
23	educational institution that:
24	(i) is not operated for gain or profit;
25	(ii) has an attendance policy; and
26	(iii) has a definable curriculum with systematic instruction;
27	(f) property, of any acreage, owned by a tribal corporation created for the sole purpose of
28	establishing schools, colleges, and universities if the property meets the requirements of subsection (1)(e);

3 (c) For the purposes of subsection (1)(i):

4 (i) the term "institutions of purely public charity" includes any organization that meets the following
5 requirements:

6 (A) The organization offers its charitable goods or services to persons without regard to race,

7 religion, creed, or gender and qualifies as a tax-exempt organization under the provisions of section 501(c)(3),

8 Internal Revenue Code, as amended.

9 (B) The organization accomplishes its activities through absolute gratuity or grants. However, the 10 organization may solicit or raise funds by the sale of merchandise, memberships, or tickets to public

11 performances or entertainment or by other similar types of fundraising activities.

(ii) agricultural property owned by a purely public charity is not exempt if the agricultural property is used by the charity to produce unrelated business taxable income as that term is defined in section 512 of the Internal Revenue Code, 26 U.S.C. 512. A public charity claiming an exemption for agricultural property shall file annually with the department a copy of its federal tax return reporting any unrelated business taxable income received by the charity during the tax year, together with a statement indicating whether the exempt property was used to generate any unrelated business taxable income.

18 (iii) up to 15 acres of property owned by a purely public charity is exempt at the time of its purchase even if the property must be improved before it can directly be used for its intended charitable purpose. If the 19 20 property is not directly used for the charitable purpose within 8 years of receiving an exemption under this 21 section or if the property is sold or transferred before it entered direct charitable use, the exemption is revoked 22 and the property is taxable. In addition to taxes due for the first year that the property becomes taxable, the 23 owner of the property shall pay an amount equal to the amount of the tax due that year times the number of 24 years that the property was tax-exempt under this section. The amount due is a lien upon the property and 25 when collected must be distributed by the treasurer to funds and accounts in the same ratio as property tax 26 collected on the property is distributed. At the time the exemption is granted, the department shall file a notice 27 with the clerk and recorder in the county in which the property is located. The notice must indicate that an 28 exemption pursuant to this section has been granted. The notice must describe the penalty for default under

1	this section and must specify that a default under this section will create a lien on the property by operation of
2	law. The notice must be on a form prescribed by the department.
3	(iv) not more than 160 acres may be exempted by a purely public charity under any exemption
4	originally applied for after December 31, 2004. An application for exemption under this section must contain a
5	legal description of the property for which the exemption is requested.
6	(d) For the purposes of subsection (1)(k), the term "public museums, art galleries, zoos, and
7	observatories" means governmental entities or nonprofit organizations whose principal purpose is to hold
8	property for public display or for use as a museum, art gallery, zoo, or observatory. The exempt property
9	includes all real and personal property owned by the public museum, art gallery, zoo, or observatory that is
10	reasonably necessary for use in connection with the public display or observatory use. Unless the property is
11	leased for a profit to a governmental entity or nonprofit organization by an individual or for-profit organization,
12	real and personal property owned by other persons is exempt if it is:
13	(i) actually used by the governmental entity or nonprofit organization as a part of its public display;
14	(ii) held for future display; or
15	(iii) used to house or store a public display.
16	(e) For the purposes of facilities for the care of the retired, aged, or chronically ill under subsection
17	(1)(n)(ii), the terms "retired" and "aged" mean an individual who satisfies the age and gross household income
18	limitations of 15-30-2338. The property owner shall verify age and gross household income requirements on a
19	form prescribed by the department. Applicants are subject to the false swearing penalties established in 45-7-
20	202."
