RE: Bill introduction of an agency bill -- preintroduction required

Dear Cory Jensen:

Enclosed is the final draft of LC0384, which was drafted at the request of your agency. The following options are available to you concerning your bill:

- 1. You must find a legislator to sponsor and preintroduce the bill. A bill request by an agency and authorized for drafting by a legislative committee must be preintroduced by 5 p.m. on December 15, 2016. If the bill is not preintroduced, the Legislative Services Division must cancel the request.
- 2. Subject to the "redo" limitations explained in your earlier review drafts, you may ask the Legislative Services Division to revise your bill further before preintroduction. However, "redo" of a bill ready for preintroduction may delay the bill and cause automatic cancellation. You may also cancel the bill draft at this time.

The Legislative Services Division will begin preintroducing bills November 15, 2016, and will continue to do so until 5 p. m. December 15, 2016. To preintroduce the bill, you must:

- find a legislator who will be serving in the 65th Legislative Session to be the sponsor of the bill;
 and
- 2. have the sponsor sign the enclosed preintroduction form and return the signed form to the Legislative Services Division as soon as possible but no later than 5 p.m. on December 15, 2016. Alternatively, the sponsor may fax the signed form to the Legislative Services Division at (406) 444-3036 or email a scanned form to legbills@mt.gov. Proxy signatures or phone authorizations will not be accepted.
