11:12:08 Sen. Ryan Osmundson gave an overview of SB 310, a joint study by the Legislative Council and Legislative Finance Committee to consider an annual session including different budgeting and policy processes for future legislatures.

11:27:27 The committee broke into five groups, as indicated by Ms. Fox, to discuss issues, principles to guide the study, and study goals while they ate lunch.

### **Round 2 – Objectives**

12:40:05 Co-Chair Dudik asked if the group wanted to stay in small groups or move to the table, the consensus was go back to the big table for discussion.

12:40:56 Amy Carlson, Legislative Fiscal Analyst, presented a distilled version of the legislator's list of goals, with an overarching goal being to strengthen the legislative branch and the relationships within it.

### **Round 3 – Discussion of potential work plan items, timeline for study**

12:43:17 Rep. Jones said he wants to ensure multiple committees with overlapping interests are in town at the same time with joint meetings.

12:45:01 Sen. Osmundson said you have to break it up in terms of cross-pollination between budget and policy and said the speaker suggested moving a standing committee to continue work in the interim.

12:47:22 Rep. Jones said committee assignments should be thoughtfully done, as it was in the Senate, but that is not possible in that matter in the house. He asked if they could define best practices and present to leadership.

12:49:10 Rep. Ballance said during her first session she was on the education appropriations subcommittee and the chairman of the House Education

Committee had meetings twice per week over the noon hour and the two committees got together and talked about what was going on in those areas. She said it worked well in terms of communication.

- 12:50:38 Speaker Hertz suggested a decompressed timeline going into session on even-numbered years to allow for newly elected legislators to work on committees before the session starts. He asked if that would be considered as they think about annual sessions.
- 12:51:36 Sen. Pomnichowski said agency and bill updates at every other interim committee meeting would be helpful to follow legislation so if something wasn't on track with legislative intent it wouldn't be the next session before they could make it right.
- 12:53:00 Sen. Thomas said a friend texted him something that made him think of the three equal branches of government. He said they dance around the problem of having no authority to act outside the session. He said the Judiciary is in effect 24 months of term and the executive branch is in effect all the time, but the legislature is constitutionally bound to 90 days.
- 12:55:02 Sen. MacDonald said her group talked a lot about managing the calendar and elongating the 90 days, a more deliberative pacing of work. She said they could include dividing 90 days into two different parts of the cycle. She said they could be more nimble and able to respond to a court decision or the executive branch. She said they have a 19th century calendar in a 21st century world.
- 12:56:39 Sen. Osmundson said it would be helpful to understand how other states do this -- they don't wait until day one to show up and start work.
- 12:58:55 Speaker Hertz said reaching out to other states would be helpful.
- 12:59:35 Sen. Pomnichowski said her group discussed changing the shape of the interim. She said they could focus more on legislative work and trying to preempt the session. She said the interim doesn't have to be study-based, they could use the interim more creatively.
- 13:00:50 Co-Chair Dudik asked Ms. Carlson and Ms. Fox if they have enough information to proceed.
- 13:01:02 Ms. Carlson said the items fit under the initial structure she suggested. She said she would want a group to get feedback from before first big meeting.
- 13:01:50 Ms. Fox said that would be helpful to get a steering committee or sub-committee.
- 13:02:39 Co-Chair Dudik said the steering committee idea made sense. She asked if a steering committee or staff would put together the study plan.
- 13:03:03 Ms. Fox said they would come up with a study plan and work with the steering committee to refine it.

13:03:51 Co-Chair Dudik said the Legislative Finance Committee already has a SB 310 subcommittee that would work well with the steering committee including Rep. Ryan, Sen. Osmundson, Sen. Jacobson and Sen. Sesso.

13:04:33 Co-Chair Dudik asked who else would like to be involved and Rep. Galt, Sen. Pomnichowski, Rep. Abbott, Sen. MacDonald, Sen. Thomas, Rep. Hopkins, and Rep. Holmlund volunteered.

13:05:42 Co-Chair Dudik asked if Sen. Osmundson could spearhead the steering committee and he said yes.
