

Most of HB 15 BASE Aid is in HB 2, so will not show on the bill list. SB 29 and HB 226 interact, so SB 29 has been removed as a duplicate from the bill list per status sheet rule #10. HB 2 language contains contingent and coordination language between multiple bills and HB 2, the status is reflected in the balance sheet. Medicaid redeterminations will begin on April 1, 2023, and the 6.2 percentage-point FMAP increase will be phased-out beginning with 5 percentage-point increase for April - June 2023.
