Enforce compliance with state laws, hold bad actors accountable, advocate for victims

AGENCY EXAMINATIONS/REVIEWS

- **SECURITIES:** Securities conducted 12 targeted BD Exams and 20 IA exams (now funded by the IA's themselves)
- INSURANCE MARKET CONDUCT: Conducted 2 market conduct examinations
- RATES BUREAU: Completed review of approximately 4,000 rate filings
- INVESTIGATIONS: For CY 2022 and 2023, Investigations has experienced a cumulative 60% increase in fraud referrals
- In CY 2023, Investigations had 76 cases referred to Legal for either administrative or criminal action
- In CY 2023, fraud reports reflected a 12% decrease in consumer fraud reports and a 100% increase in producer fraud reports




- **LEGAL** prosecuted criminal administrative insurance fraud statewide, with 56 enforcement actions filed in 2023 and nearly \$1.5 million in ordered fines and restitution
 - Securities Enforcement Actions (5), resulting in over \$600K in ordered fines (CY2023):
 - Nexo Capital \$212,264.15 fine ordered (1/31/23)
 - Lavish Auto \$10,000 fine ordered (10/26/23)
 - Raymond James \$100,000 fine ordered (11/16/23)
 - Vbit \$180,000 fine ordered (9/25/23)
 - Robinhood \$100,000 fine and \$100,000 in restitution assistance fund payment
- Working with U.S. Attorney's office on several joint federal-state investigations and prosecutions
 - ▶ In early 2023, CSI completed an investigation into premium diversion activities of Kileen Hagadone, owner of Rosebud County Insurance, Inc. She recently pled guilty in federal court to wire fraud and to aggravated identity theft. Hagadone faces a maximum of 20 years in prison, \$250,000 fine and three years of supervised release on the wire fraud crime and a mandatory minimum of two years in prison (consecutive to any other punishment), a \$250,000 fine and one year of supervised release on the aggravated identity theft crime.
- CSI FINANCIAL ABUSE SPECIALIST TEAM processed 28 referrals to date in 2023 of elder abuse, a 350% increase over 2022; referrals Complete initial review of referrals within 72 hours. Complete annual tracking of referral and outcomes
- 23 referrals resolved year to date that included coordinated responses by various agencies to bring justice to elderly Montanans
- **LEGAL**: CSI has almost doubled the number of criminal enforcement actions filed in 2023 compared to 2022, while cutting our outside counsel fees by 43%



INTER-AGENCY EFFICIENCY

Promote effective, efficient, and transparent management and stewardship of state resources

- INVESTIGATIONS/SECURITIES INVESTIGATIONS CASE MANAGEMENT SYSTEM (SIIMS):
 Commenced in 2023 as a means of improving our investigative process to reduce administrative time in tracking and documenting investigations, provide a central secure depository for documents and evidence, provide robust reporting to identify insurance fraud trends in the state, and provide easier access to reporting for consumers. Currently, implementation is the final stages of development with the contractor, with beta testing and commissioning anticipated in the first half of 2024
- INSURANCE—INVESTIGATIONS AND INSURANCE COMPLIANCE SERVICES: These two bureaus were combined into one, creating efficiency and synergy
- **LEGAL:** CSI has almost doubled the number of criminal enforcement actions filed in 2023 compared to 2022, while cutting our outside counsel fees by 43%
- RATES: Streamlined agency's ACA and Medicare Supplement online resources
- **AGENCY:** 70% of agency has completed comprehensive desk-level policies and procedures inventory, review and consolidation. Intranet has been created for master repository
- Promote and support of staff development
