In Arizona, the Board of Visitors is the oldest women's charitable organization in the state

In New York, the Board of Visitors operates as a non-profit organization

What is the Board of Visitors?

Independent board of inquiry and review established by the Legislature in 1975 to provide consumer-oriented oversight of Montana's public mental health facilities to ensure that patients of Montana's public mental health facilities (voluntarily or involuntarily) are treated humane and receive clinically appropriate and professional treatment.

Mission Statement

The Mental Disabilities Board of Visitors

provides independent oversight and critique of treatment provided by the Intensive Behavioral Center and Montana's public mental health programs and makes recommendations for their improvement;

Mission Continued...

The Mental Disabilities Board of Visitors works to ensure that everyone with a mental illness or developmental disability receiving services in the Intensive Behavioral Center and Montana's public mental health facilities has access to effective, evidence-based treatment and supports that are essential for living, working, learning, and participating fully in the community.

Board of Visitors Composition

The Board is a 6-member Board, members are appointed by the Governor.

Board members serve two-year terms, with half of board members term expiring at the end of the fiscal year (June 30th).

Board slots are compromised of designated mental health and developmental disability professionals, individuals with experience in treating adults and children with mental illness, and primary or secondary consumers of mental health or developmental disabilities service

What is the Boards Function?

Conduct site inspections/reviews of Montana's public mental health facilities, including MSH, MMHNCC, and IBC. (Annual inspection of IBC)

Purview of Board includes any hospital, behavioral inpatient facility, licensed mental health center, residential treatment facility or residential treatment center licensed or certified by the department that provides treatment to children or adults with a mental disorder.

The Board makes attempts to utilize professional and consumer consultants during site inspections.

The Board must review and approve all plans for experimental research that would involve any individual admitted to a mental health facility.
