## **Long-Term Care Funding**

In order for Montana to address the state's long-term / senior care crisis, we need to fund provider rates at the level the Guidehouse Study recommended: we will continue to face staffing shortages if our long-term health care providers are not paid a competitive wage. We need to support Montana providers who've been in this work for decades. We need to properly fund and support Montana workers. If we do not, Montana families will continue to struggle to find local, affordable long-term care. 11 nursing homes and counting closed already. That means Montanans parents and grandparents are shuttled further and further away from family as their community nursing homes close down. Rural communities rely on these facilities.

My adult son is severely mentally ill. Dedicated workers should not have to sacrifice their health and financial security and that of their families caring for MT's most vulnerable people. Vulnerable Montanans need to be cared for in their homes, and communities, by friends and neighbors close to their loved ones. Vulnerable Montanans should not have to leave their communities and homes to get the care they need.

The administration should immediately engage the public, providers, and families in the Governor's plan for mental health. MT has a mental health crisis and a crisis with nursing homes closing. In order for Montana to address these tragedies we need to fund a competitive wage. If we do not, Montanans will struggle to find affordable and accessible mental health care.

Democrats fought for increases in Medicaid services and provider rates. The Governor said, no, we need to study the obvious instead and base decisions on data. #### **Mental Health Services**

➤ I serve on the Kalispell City Council, though I am only commenting on behalf of myself personally.

A lack of adequate funding for mental health services has resulted in the closing of our local mental health facility and a lack of resources for other mental health services locally. This has resulted in a crisis in our community with a rapid deterioration in the mental health for some of our most vulnerable residents, including members of our homeless population. Local businesses and other residents are experiencing the effects of this crisis with increasingly difficult behavior being exhibited by those with mental health challenges in our community. It is falling on our already stretched thin law enforcement to deal with consequences of untreated mental illness. I can't stress enough how critical the situation is in our community.

In addition, we have experienced a spike youth suicides in our community in recent years. We must do more to help our teens and veterans struggling with mental health challenges.

For these reasons, I urge you to support funding Medicaid provider rates at the level in the Guide House study and to increase funding through marijuana sales revenue for the HEART program. Thank you.

Montana Mental Health. For the past 4 years, I have been the Co-founder and Executive Director of the Flathead Warming Center (low-barrier homeless shelter). I have witnessed our local mental health resources dry up after the 2017 Medicaid Reimbursement Rate cuts for mental health adult case management services. Case management has disappeared and our entire community is suffering as a result! I have seen severely ill individuals go from having case management services, being medicated, and stable in our community to now, without case management services and a place to stabilize, these same individuals are homeless, unmedicated, no mental health support system, and wondering our streets and other public places. Those struggling with severe and disabling mental illness MUST have the one-on-one caring relationship with a professional in our community to navigate life with mental illness and to regain stability when symptoms of their mental illness become acute. Currently, case management does not exist for a large percentage of the mentally ill population and when their

life falls apart, we no longer have mental health crisis stabilization facilities for people to go to become well. A crisis stabilization house in the Flathead has been CLOSED for over a year! Without the resources needed in our community for individuals to be well, as a community, we have no other option but to pass individuals between shelters, the emergency room, law enforcement, and jail. Again, and Again and Again. This is INSANITY! And is EXPENSIVE! I must paint a picture of how the lack of case management services and crisis stabilization care is being played out in our community. We have mentally ill individuals who have lost limbs due to severe frostbite. Our community could not help them! We have individuals released from the Montana State Hospital directly back into homelessness, dropped at the shelter door without a connection to services, because case management no longer exists! One such individual, discharged from the State Hospital, dropped in our local community, without local mental health care, dealing with extreme psychosis, cut off his entire genitalia in the Warming Center bathroom! The condition and void of mental health services in our Montana communities is extreme! When those with severe and disabling mental illness have difficulty getting even their basic needs met, it comes out sideways and is ugly. We are seeing dangerous and poor behaviors in local parks and throughout the community. We do not have the crisis stabilization facilities nor space in the jail, so these individuals are not being helped nor held accountable for their dangerous and disruptive behaviors within our community! Again, they are being passed around. What is now being played out in our public spaces is the direct result of case management services and crisis stabilization being nonexistent. I fear we are not even seeing the worst yet! Case Management services is absolutely vital to a community's health and safety! PLEASE HELP Montana communities to have healthy local mental health services! PLEASE bring back an appropriate Medicaid reimbursement rate for all mental health services! And please do it as SOON as you can. This is a good starting point; just a starting point!!!! We are in dire need!!!!!!"
