➤ "My organization, Opportunity Resources in Missoula, MT, has had to cope with a staffing decrease of 65 people in the past 2.5 years due to the pandemic and the inability to pay them a living wage. This has caused ORI to have to close one congregate living site altogether and limited our ability to provide new services to individuals with disabilities on the waiting list.

We are grateful that a rate increase is being considered from the governor's budget, but frankly 4% is not enough to make a difference with being able to hire adequate staffing levels. As a 31-year veteran of providing employment services and enhancing the independence of persons with disabilities, I ask that you consider fully funding the full rate increase called for in the rate study that was recently published."
