
3 Programs 119.66 HB2 FTE – 19.2 vacant (16%)

**Central Services (19.0):** Provides essential business support to the department, including financial, information technology, human resources, legal, and public information support.

#### **Agricultural Sciences Division (61.79):**

Administers the major activities related to pest, pesticide, and noxious weed management; seed, feed, fertilizer, nursery, produce safety, and hemp programs; analytical and chemical groundwater laboratory services; and organic and export certification.

Agricultural Development Division (38.87, plus 3.78 statutory positions): Assists industry by providing market and agribusiness development, grants and loans, wheat, barley, and pulse crop research, grain grading and inspection, and hail insurance.



The director's office provides leadership to staff and oversight of operations, and communications with the Ag industry and media.

Ensures the department's goals and missions are developed in collaboration with industry, as well as senior leadership.

The director guides and assists the leadership team in following the mission of the department.

The senior leadership team consists of two administrators, one of whom also serves the role of deputy director. Additionally, chief legal, communications officer, chief financial officer, and recently added our business operations officer comprise the remainder of the senior leadership team.



Improve licensing and registration efficiency through restructure

Turnaround time reduced to less than 30 days

Program manager position repurposed for field inspector

Maintained ~50,000 licenses, registrations, certifications, and inspections across 25 programs

Collected nearly \$8 million in fee-for-service revenue per year

Awarded \$2.2 million in Noxious Weed Trust Fund Grants to all 56 counties and 4 tribes


Collected ~100 groundwater samples per year to monitor pesticides. No detections exceeded drinking water standards.



### ONGOING FUNDING: \$380,000 EACH YEAR

15002: Federal Indirect Cost Rate Increase of \$100,000 each year

30002: SAFHRS System Maintenance of \$50,000 each year (HB10 request for system implementation)

30004: Various Agricultural Sciences Increase of \$190,000 each year

30009: Chromatography Instrument Maintenance of \$20,000 each year (OTO request below)

50004: Commodity Assessment System Maintenance of \$20,000 per year (HB10 request for system implementation)

### ONE-TIME ONLY FUNDING: \$236,000 IN FY2024

30003: Lab Combustion Analyzer - \$86,000

30008: Chromatography Instrument - \$100,000

50005: Hail Insurance System - \$50,000



## One-Time Only General Fund Request

**30010: Hemp Program Resources** for \$125,000 each year to mitigate the compliance costs with federal laws that are in flux

#### 50001: State Grain Lab Resources

for \$250,000 each year to alleviate past cash deficit until the operational efficiencies and rate increases can be realized






## Industrial Hemp, MCA 80-18-1

### State Grain Lab

MCA 80-4-7

Located in Great Falls and Plentywood •Only USDA Federal Grain Inspection Service in Montana

- Official USDA inspection required for foreign trade
- Monitored by Federal Grain Inspection Services (FGIS)
- More reliable, consistent, and unbiased testing, grading, inspection results

#### •Commodities Inspected include:

- Wheat, barley, oats, rye, corn
- Green, yellow, and mottled peas, chickpeas, lentils, navy and pinto beans
- Canola, safflower, sunflower, soybeans, mustard


•Primarily operates on income generated from fees and services rendered
