*Garfield County declined their award for the Garfield County Museum; Montana Heritage Commission returned their award for the Hickman House; Friends of the Historical Museum at Fort Missoula returned their award for the Historical Museum at Fort Missoula; and Community Health Care Center, Inc., dba Alluvion Health’s contract was terminated as they did not meet the start-up requirements. The declined, returned, and terminated awards returned reduced the total awarded by \$1,141,273.00.

**Original Montana Club Cooperative Association sold the Original Montana Club and the new owners intend to request approval from the Legislature to reassign the 2025 biennium award.
