Project Rollout & Priorities (68th session only)



A&E PROJECT MAP

Status of all current A&E projects



Shifting from Procurement to Execution

58 Architecture & Engineering Firms under Contract. 146 Projects in Planning & Design, 65 Projects in Construction.

Tracking Uptick on Volume of Projects to Manage:

Average # of projects/project manager pre-68th Session: 15 projects/PM Average # of projects/project manager post-68th Session: 24-30 projects/PM

98% of 68th Session Projects released to A/E & Construction Industry

Last 2% awaiting final decisions by others. A&E will be ready.

Montana State Prison HB 817 & Low-Side Housing Construction Montana State Hospital Compliance Recertification Completion Montana State Hospital Replace Water Main Quality of bids for MSU Nursing and Gianforte Hall Comprehensive ROWS Implementation of Initial Phases



Update on HB 817: Capital Projects @ MT State Prison



Low-Side Housing:

Early projections showed net gain of 117 beds at Deer Lodge without adding FTE's.

However, utilities are undersized and need substantial upgrades.

Cost & schedule comparisons of pre-fabricated cells continues.

Construction start date for low-side housing is Spring 2025.

Project Milestones:

\$4.8M for 5 Roof Replacements awarded in June 2024 Maintain current design schedule.

HB 5 Select Committee on Corrections Facility Capacity & System Development met this week:

Planning for Dept of Corrections is concurrent and informed by population studies and projections by this committee.

A&E's understanding is final report to Leg Finance and Law & Justice interim committees prior to submission to the Governor and the 69th legislature.

Update on HB 856: ROWS Implementation & Leg Branch Long-Range Plan



R.O.W.S. Implementation

Architect and General Contractor/Construction Manager under contract. Strategic planning ongoing to identify final scopes and budget for each.

Metcalf Building renovation construction start date anticipated in Spring 2025.

Legislative Branch Long-Range Plan

Legislative Council accepts the Legislative Branch Long-Range Plan identifying a need for more legislative space.

A Mid-Range plan was approved providing additional hearing rooms following 69th legislature.

LAD move was approved from the Capitol to Mitchell 4th Floor West.

Space reallocations with furniture solutions in advance of the 69th legislature.

Coming Soon:

Pilot projects to showcase furniture and renovated space in support of hybrid office work environment.

Update on HB 872: Capital Projects for Behavioral Health System for Future Generations



Reporting Timelines:

The BHSFG Commission issues draft report in May 2024 which included 21 recommendations and 5 near-term initiatives.

The Commission will bring a further draft report before various legislative interim committees in July before submitting the final report to the Governor.

Capital Projects:

\$75M appropriated to DOA for Capital Projects **after** administrative rules have been adopted and **after** the Commission transmits its final report.

Next Steps:

RFQ for architectural services to be issued **pending rule-making and Commission** action per 872 requirements.







- Data does NOT include "supplemental" funded projects already in the pipeline (1 holding, 3 initiated, 9 in design, 30 in construction, 1 complete)














Making sense of the charts:

HB 5: The Last Word



Shifting from procurement to design/bid/build requires patience.

Contracting with Owner-Rep Services helps but still requires A&E oversight.

Bid packages for the bulk of appropriations is yet to come.

Market Trends in Context: Billing Index









Backlog (in months)
Positive in terms of financial outlook
Negative in terms of immediately available capacity

The AIA/Deltek Architecture Billing Index (ABI), often viewed as a 9-12 month forward-looking indicator of construction activity, still indicates that billings continue to decline at most architectural firms. "Continued high interest rates make it difficult for some projects to move forward, but there is ongoing interest in pursuing these projects once conditions improve."








Market Trends in Context: Backlog



National Construction Backlog Indicator

(-0.1 1-Month Net Change)



West Regional Construction Backlog Indicator

(+1.8 1-Month Net Change)

Backlog = the amount of work, measured in months, that construction companies are contracted to do in the future.

The more backlog, the more positive the outlook for the construction industry.
