08:04:18 Sen. Daniel Salomon-R called the meeting to order at 8:04 AM. The committee secretary took roll.

08:08:03	Susie Lindsay, Legislative Fiscal Division (LFD) reviewed FY 2022 Financial Summary Report. EXHIBIT 1
08:11:04	Rep. Jones asked for clarification on the General Fund Balance Estimate Revision.
08:11:28	Rep. Hamilton asked if funding for Federal Medical Assistance Percentage (FMAP) will continue beyond fiscal year 2022.
08:12:06	Quinn Holzer (LFD) explained that FMAP funds will continue until the Secretary of Health declares the pandemic emergency over and then the funding would be reduced periodically until ending.
08:12:56	Ms. Lindsay continued explaining Fire Fund Update, Transfers to Reserve Balance, Inflation and General Fund Reserves.
08:16:59	Rep. Jones questioned the relatively low inflation rate forecast used to evaluate the erosion of the financial reserves.
08:17:45	Amy Carlson (LFD) replied that IHS is a standard source for inflation forecasts and she offered to do more research on inflation rate forecasts before the March meeting.
08:18:21	Rep. Jones believes the inflation rate used is too low.
08:18:49	Ms. Carlson offered to send an update in January on the new projected inflation rate and will notify the committee as projections changes in their monthly reports.
08:19:36	Chair Salomon clarified this is a data request.
08:19:48	Ms. Lindsay continued her report.
08:24:24	Rep. Regier asked how many of the state agency vacancies are filled with

contract or modified employees.

08:24:46 Ms. Lindsay explained that the study just looked at actual positions, not modified positions. She then explained the Power BI tool available on the website and the Statutorily Required Reports. Ms. Carlson pointed out that the Financial Summary Report is a condensed, high 08:26:41 level view created for this committee and she is open to suggestions for improvement. She also passed out Appendix C: Detailed Budget Amendments Report. **EXHIBIT 2** 08:27:40 Sam Schaefer (LFD) gave a report on YTD General Fund Revenue, Major Sources, and Individual Income Tax Estimates, from FY 2022 Financial Summary Report. 08:25:35 Rep. Caferro joined the meeting. 08:30:42 Rep. Stewart Peregov joined the meeting. 08:35:10 Rep. Jones pointed out that since we are back to 2019 employment levels of actual workers, the increase in withholding must be attributed to wage inflation. Mr. Schaefer agreed that a significant portion of the withholding increase was 08:35:59 due to wage inflation but there are other factors as well. 08:37:47 Sen. Jacobson asked if taxes are being collected from remote workers living in Montana and do Montana employment figures account for those remote workers. 08:39:10 Mr. Schaefer explained that people physically present and working in the state are required to pay Montana taxes, but tracking compliance is difficult. Also, he would need to research further if Montana unemployment figures include remote workers. Sen. Jacobson questioned if the increase in withholdings is sustainable. 08:41:40 08:42:42 Mr. Schaefer said he will analyze new resident income compared to current resident income for the March MARA meeting. 08:43:34 Vice Chair Caferro asked for clarification on what "wage inflation" means. Mr. Schaefer defined wage inflation as growth in wages beyond what we would 08:43:55 typically see. 08:46:06 Vice Chair Caferro asked if the current wage levels are the new baseline. Mr. Schaefer explained that forecasts will be used to determine the baseline for 08:46:20 wages. 08:46:48 Rep. Hamilton asked what the reduction in labor force participation is in Montana. 08:47:07 Mr. Schaefer will research that number for Montana. 08:47:30 Rep. Jones commented that there are more people working today in Montana than in 2019. 08:48:19 Sen. Cuffe followed up on the wage inflation discussion and pointed out that temporary medical workers inflate wages beyond what a permanent employee doing the same type of work would receive. 08:49:22 Mr. Schaefer agreed, but the overall impact depends on what portion of total wages is being driven by those temporary positions. 08:50:43 Rep. Jones pointed out that while revenue is up, we will soon see an increase in expenses for state employee wages. Ms. Carlson pointed out that the Department of Labor job tracker website will be 08:52:40 posted on the materials page of the committee website. Mr. Schaefer said that the wage growth baseline will not likely remain at the 08:53:17 current level and will be reevaluated over time.
