SUBJECT: Legislative Reporting - Location of Individuals 10 days after Sentencing
DATE: November 30, 2021

Pursuant to House Bill 693:

Beginning July 1, 2021, and each quarter of the 2023 biennium, for the quarter preceding the report, the department of corrections shall report to the law and justice interim committee and the legislative finance committee on:

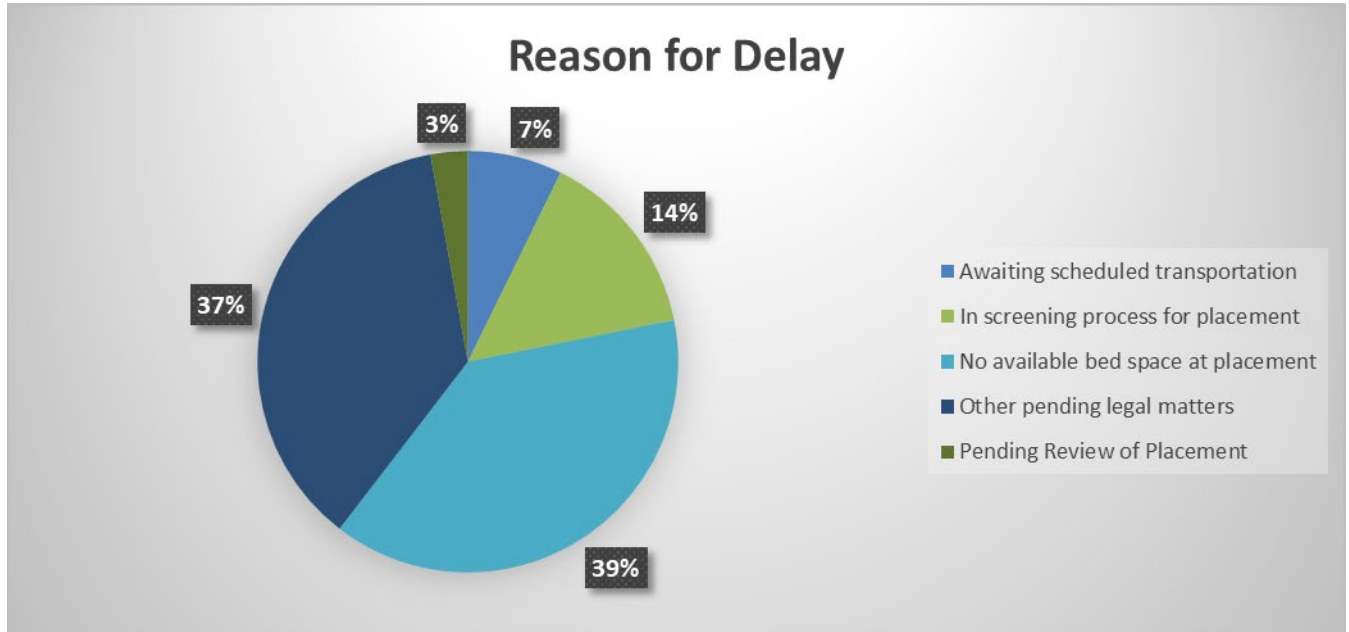
- a) the number of occasions a defendant sentenced for one or more felonies remained in a county detention facility for more than 10 business days after sentencing;
- b) the names of the defendants who remained in a county detention facility for more than 10 business days after sentencing and the county detention facility in which they were held; and
- c) for those defendants remaining in a county detention facility for more than 10 business days after sentencing, on the relevant facts leading to the delay in transfer out of the facility and whether the delay is attributable to untimely receipt of a judgment or other sentencing documents from the judicial branch.

Overview:

For the period of July 1, 2021 to September 30, 2021, 316 defendants remained in county detention facilities for more than 10 business days after their sentencing. The reasons for those delays in order of frequency include:

- a) No available bed space at placement (39 percent) – This delay relates to a lack of open beds at a facility, such as a prerelease or treatment center, at a given time. However, contributing to this number are restrictions related to COVID-19 and quarantine requirements of the accepting facility.
- b) Other pending legal matters (37 percent) – This delay relates to offenders who have pending legal matters aside from those for which they were sentenced that must be resolved before movement may occur.
- c) In screening process for placement (14 percent) – Pursuant to statute and contract, community corrections facilities have screening committees that determine whether to accept an offender’s application for placement. Offenders in this category are in the process of being screened by facility screening committees. This process could include multiple facilities should the offender’s application be rejected.
- d) Awaiting scheduled transportation (7 percent) – Offender transports may involve multiple offenders traveling from a variety of locations to multiple destinations. Scheduling takes into account these factors along with COVID-19 restrictions, weather conditions, and other variables. As such, it occasionally takes longer than 10 days to coordinate statewide offender transportation between and among detention facilities, prisons, and community corrections facilities.

- e) Pending review of placement (3 percent) – Each offender placement must be reviewed by the appropriate DOC staff to ensure the placement is appropriate. In some instances, this process may exceed 10 days for extenuating circumstances.
