Members of the Interim Budget Committee Section D,

The Montana Department of Corrections respectfully submits the following information in response to questions posed by members of the Interim Budget Committee Section D on Dec. 15, 2021.

DOC Reorganization

The department restructured its organization in 2021 to focus on its major functions – Central Services, Public Safety, and Rehabilitation and Programs. Those functions are now led by three chief executive officers. The department also brought on a chief financial officer, whose efforts are solely focused on the department's budget and working with OBPP. Plus, the department established customer service and facilities manager positions. These positions were created by repurposing existing positions

Risk Assessments

Pursuant to the justice reinvestment legislation passed by the legislature in 2017, an offender must receive the type of supervision and programming that provides the best outcomes possible for that individual. To establish a foundation for this work, the department partnered with the University of Cincinnati to identify appropriate tools for measuring an offender's individual needs and level of risk. The assessment tools selected, the Montana Offender Reentry and Risk Assessment (MORRA) and Women's Risk and Needs Assessment (WRNA), are standardized and validated evidence-based instruments used to:

- Assess the probability of an offender recidivating
- Identify risk factors and criminogenic needs to guide and prioritize programming
- Enhance sharing of offender information
- Assist in the efficient allocation of resources while an offender is under department supervision.

*The MORRA and WRNA have been validated. The DOC will norm the tool on Montana's offender population once a statistically sufficient number of assessments have been performed in the state.






The Risk Principle – focus the most intensive resources on individuals most likely to commit crimes to have the largest impact on recidivism

With Risk Assessment...





The Need Principle – focus on dynamic criminogenic needs directly associated with individual criminal behavior to impact the most positive change






By using the MORRA and WRNA, the DOC can determine offenders' unique risks and needs and match them with programming targeted at addressing those issues, the level of supervision appropriate to help keep offenders on track, and ultimately, reduce their risk of recidivism. As an extension of these assessments, the DOC can better allocate resources, like probation and parole officers, based on level of risk for recidivism.

The most effective programs at reducing recidivism use a cognitivebehavioral approach

Cognitive-behavioral programs include:

- Demonstration of new skills
- Require participants to practice new skills
- Graduated skills practice

WATCh East Transition (Explanation, update)

Historical Events Impacting Correctional DUI Treatment Bed Usage

Two significant changes in the state's policy landscape have led to a decrease in the usage of contracted correctional DUI treatment bed usage. Those include:

- The expansion of Medicaid in 2015 increased behavioral health access in communities and created a
 payment source for adults who previously did not qualify for Medicaid coverage.
- Building upon Medicaid expansion, felony treatment courts began appearing in counties all over the state, with a current total of 36 treatment courts serving 608 offenders, many of whom would have previously been placed in a correctional treatment bed.



Timeline

1996	First Drug Court established in Montana (Missoula)
2009	First DUI Court established in Montana (Billings)
April 2015	Medicaid Expansion, via the HELP Act, implemented
July 2017	Legislature amends DUI laws to allow courts to place individuals convicted of 4 th DUI in treatment courts as an alternative to being committed to the DOC with placement at WATCh.
October 2021	As of 10/31/2021, there were 608 adults participating in adult drug courts or family drug courts in Montana. Thirty-six drug courts are operating in Montana.

DOC Adaptation to Shifting Landscape

As noted, statewide policy changes have had a significant impact on the use of DUI treatment beds. In response to a declining population at WATCh West, DOC worked with its contractor on mutually agreed upon amendments to its contracts for WATCh West and CCP West¹ in mid-2018 to decrease beds in one program and increase beds in the other. However, bed usage at the DUI facilities has continued to decline.

While it is anticipated that the recently issued placement guidance for staff – based upon legislative direction in HB 2 in 2021 - will lead to increases in placements at 90-day and 9-month SUD treatment programs, it is not expected that DUI treatment facilities (WATCh West and WATCh East) will see this same increase. These programs offer treatment and programming specific to the crime of DUI, whereas the other facilities offer more general treatment and programming to offenders. Additionally, HB 115 (2021) provides increased penalties for those with 5th and subsequent DUIs, which may result in increased prison placements for offenders versus community corrections placements.

Opportunities Moving Forward

A significant need exists in Montana for non-correctional treatment facilities that accept Medicaid as a payment source. Currently, the lack of these treatment beds – or lengthy waitlists – means that treatment is often not an option as a front-end diversion in the criminal justice system. Because the DOC owns the Eastmont facility, the department will lease the facility to a provider to operate a Medicaid-reimbursable SUD treatment facility that will fill a critical void in the continuum of care in eastern Montana.

Correctional Officer vacancies and appropriate minimum staffing levels

At MSP - Of the 328 correctional officer staff positions at Montana State Prison, about 20 percent are unfilled at any given time. Mandatory posts must be filled in order to ensure the security and safety of staff and inmates. To accomplish this, staffing assignments are adjusted to cover mandatory posts, which affects other activities (Rec Yard, Gym, etc.) In addition, overtime hours are regularly offered to correctional officers to fill as many posts as possible. If volunteers are lacking, mandatory overtime is implemented.

At Crossroads Correctional Facility – As is the case at MSP, Crossroads has challenges staffing all of its correctional officer positions. The DOC monitors this closely as staffing requirements are outlined in detail in the state's contract with CoreCivic, with assessments levied for failure to staff. Like at MSP, staffing assignments are adjusted to fill mandatory posts, with voluntary and mandatory overtime used when necessary. Crossroads may also draw recruits and temporary employees from CoreCivic's numerous facilities throughout the nation.

Inflationary Effects on MCE

Montana Correctional Enterprises is experiencing the effects of inflation in many areas of its business. The most notable include the cost of:

- Paper
- Diesel fuel
- Containers and shipping material
- Electricity
- Freight Expenses
- Wood
- Food
 - The Consumer Price Index for meat increased by approximately 16 percent
- · Finishing materials for Industries products

In addition, the price of aluminum for MCE's License Plate Factory increased from \$1.92/lb to \$2.65/lb. Freight for the factory's recent aluminum order was \$2,000 more than past deliveries. MCE expects an approximate \$116,800 cost increase for FY2022.

Also on the horizon, MCE anticipates a 42 percent increase in fertilizer costs as predicted in the Farm Report.

Contract Facilities (1 percent increase)

Included in HB2 in the 2021 Montana Legislative Session was funding to provide a 1 percent increase for nonprofit contract facilities for each year of the biennium —\$508, 498 for FY22 and \$509,164 for FY23. Unfortunately, it appears a mathematical error was made when these amounts were calculated. To truly support the increase in each year of the biennium, the amount for FY2023 should be approximately double the amount provided for FY2022.

The department identified funding in its budget to support the required FY2023 increase for this biennium. However, the DOC does not anticipate having this money available on an ongoing basis, and plans to bring a request next legislative session to correct the error.

SUBJECT: Legislative Reporting - Location of Individuals 10 days after Sentencing

DATE: February 10, 2022

Pursuant to House Bill 693:

Beginning July 1, 2021, and each quarter of the 2023 biennium, for the quarter preceding the report, the department of corrections shall report to the law and justice interim committee and the legislative finance committee on:

- a) the number of occasions a defendant sentenced for one or more felonies remained in a county detention facility for more than 10 business days after sentencing;
- b) the names of the defendants who remained in a county detention facility for more than 10 business days after sentencing and the county detention facility in which they were held; and
- c) for those defendants remaining in a county detention facility for more than 10 business days after sentencing, on the relevant facts leading to the delay in transfer out of the facility and whether the delay is attributable to untimely receipt of a judgment or other sentencing documents from the judicial branch.

Overview:


For the period of October 1st, 2021 to December 31st, 2021, 251 defendants remained in county detention facilities for more than 10 business days after their sentencing. The reasons for those delays in order of frequency include:

- a) No available bed space at placement (37% percent) This delay relates to a lack of open beds at a facility, such as a prerelease or treatment center, at a given time. However, contributing to this number are restrictions related to COVID-19 and quarantine requirements of the accepting facility.
- b) Other pending legal matters (32% percent) This delay relates to offenders who have pending legal matters aside from those for which they were sentenced that must be resolved before movement may occur.
- c) In screening process for placement (31% percent) Pursuant to statute and contract, community corrections facilities have screening committees that determine whether to accept an offender's application for placement. Offenders in this category are in the process of being screened by facility screening committees. This process could include multiple facilities should the offender's application be rejected.


