<u>Please note:</u> Legislative leadership has the authority to revise the schedule, including the days the Legislature meets and the proposed breaks.

Introduction deadlines: Generally, bills and resolutions must be introduced within 2 legislative days after delivery. JR 40-50. However, House rules provide for introduction within 48 hours from the time that the bill was accepted from the Legislative Services Division and provide that "[n]o bill or resolution may be introduced any later than 5 p.m. 5 legislative days prior to the appropriate transmittal deadline." H40-10.

"General bills" is used to denote all bills, except appropriation or revenue bills, and all joint resolutions.

Notes: Deadline dates are determined according to legislative days, using a 6-day legislative week.

Certain bills and resolutions relating to administrative rules may be transmitted at any time during the session. JR 40-200(3).
